TONY'S PIZZA EVENT CENTER POLICIES AND REGULATIONS

The following policies apply to Tony's Pizza Event Center parking areas and all areas surrounding.

1. CHECK IN starts at **12:00pm on: WEDNESDAY MARCH 3, 2021**
2. CHECK OUT is **12:00pm on: MONDAY MARCH 8, 2021**
3. Lights OUT: 11:00pm-6:00am Quiet HOURS: 10:00pm-7:00am
4. RV Reservation is for the entire event (5 nights) is \$100.00. *Cannot be split into individual days.*
5. Parking Permit with number visible MUST BE DISPLAYED in trailer and tow vehicle at all times.
6. Parking of additional vehicles are allowed in designated area only.
7. All spots are 30AMP Hookups. Only one hookup is allowed per site.
8. There are **NO WATER HOOKUPS available at this site. Must use onboard fresh tanks.**
9. NO GREY WATER dumped on the ground. Trailers will be removed at owner's expense if violation occurs.
10. Quiet Hours are from 10:00pm-7:00am. This includes generators, radios, TV's, loud voices, barking or whining of animals or running vehicles will NOT be allowed during Quiet Hours. Noise must not emit past the assigned camping area.
11. All trailers, including awnings and hitches, and ANY vehicles must fit in assigned area. No encroaching onto other campsites.
12. Persons under 18 years of age must be accompanied by a parent or guardian to camp overnight.
13. Pets must remain on leash, no longer than 8' at all times. Pets are NOT allowed inside any of the facilities. Only pets that are approved by the KSA 39-1101 Use of Service Animal Act are allowed inside the facilities.
14. Pet handlers must remove and properly dispose of all waste from pets.
15. Trash must be removed and disposed of in large dumpster on the south side of the Event Center daily.
16. RV Site is to be kept clean and orderly at all times and should be cleaned upon completion of stay.
17. Hunting or the use of firearms, bow and arrow, air or gas weapon, or other projectile devices capable of injuring or killing any person or animal or damaging or destroying property are prohibited.
18. Open fires are not permitted. Fireworks are also not permitted.
19. All Event Guests/RV Reservation Guests must abide by the Event Center Hours during the Event. Any guests that attempt to trespass into the Event Center after hours will be prosecuted to the full extent.

HOLD HARMLESS DISCLAIMER:

- Camper agrees to carry his or her own liability and comprehensive insurance and vehicle registration during the term of this rental period on their trailer.
- This rental agreement contains the entire agreement between Tony's Pizza Event Center and the camper. No other representation or inducement, verbal or written, has been made which is not contained in this rental agreement. This agreement is severable, if one portion is invalid, the remaining portion will, never less, remain in full force and effect.
- It shall be within the authority of Tony's Pizza Event Center, or their representative, to remove from the Parking Area any or all members of a group whose behavior, and any time, conflicts with County, City or State Laws, becomes detrimental to the health and safety of the group or other campers, or becomes so unruly as to affect the reasonable enjoyment of the other campers or event guests.
- The camper accepts camping privileges with the understanding that he or she does hereby release Tony's Pizza Event Center, its officers, volunteers, fellow campers and employees of all liability for the loss or damages to any property or injury to his/her person arising out of his/her use of its camping facilities and agrees to indemnify the campground, its officers, volunteers, fellow campers and employees, against claims resulting from loss or damage to property or injury to the person(s) or visitor(s) of any member of the family of the camper, arising out of the use of its camping facilities and any activities, games, or event sponsored by Tony's Pizza Event Center.
- I agree to pay for any damages to Tony's Pizza Event Center Property, sites, buildings, facilities, equipment, or loss of equipment, which may occur. Camper also agrees to immediately report any accident, injury or property damage to the Event Manager or staff. If a hazard or dangerous situation exists on the premise, the said camper will notify the Event Manager or staff immediately.
- I agree to take full responsibility for myself and all people in my party, including minors and visitors, and will require them to read and comply with all campground rules and regulations as posted in the office or on the grounds, as well as the terms and conditions as set forth in this application form.
- I accept full responsibility for my children and those children in my care, custody or control, and will supervise and attend to my children at all times while on premises.
- I request that the staff of the Tony's Pizza Event Center connect my recreational vehicle or motor home to an electrical power source for the duration of an event being held on premises. I understand that some of the sites available for recreational vehicles require that the electrical supply cable be placed over driving lanes of a parking lot and, therefore, there is a potential for damage to that cable.
- I have been made aware of the possibility of damage to my electrical power supply cable by vehicles crossing these driving lanes and that I do want my cable connected in this manner.
- I understand that, if damage does occur to my cable or to my vehicle as a result of the placement of my cable in this manner, I will assume full responsibility for said damage. Furthermore, I waive any claim to the Tony's Pizza Event Center or the City of Salina, Kansas for said damage.
